## Subject: <u>Intimation of record date under Regulation 60 of the Securities and Exchange Board of</u> India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR")

We refer to our intimations dated August 11, 2023 and August 12, 2023 (read with the corrigendum dated August 14, 2023), whereby it was intimated by the Company (*defined below*) that vide an order passed on August 11, 2023, the Hon'ble National Company Law Tribunal, Kolkata, ("NCLT") approved the resolution plan submitted by National Asset Reconstruction Company Limited ("Approved Resolution Plan"), for Srei Infrastructure Finance Limited ("Company") and Srei Equipment Finance Limited under Section 31 of the Insolvency and Bankruptcy Code, 2016.

One of the steps for the implementation of the Approved Resolution Plan is the delisting of the Non-Convertible Debentures ("NCDs") of the Company from the Exchanges. It may be noted that the delisting of NCDs is being undertaken in terms of Approved Resolution Plan consequently, the provisions pertaining to delisting of NCDs as provided for in chapter VI of LODR are not applicable.

Therefore, pursuant to regulation 60 and other applicable provisions of the LODR, we hereby intimate the record date for delisting of the following NCDs issued by the Company:
