### vi. Institutional set-up for liquidity risk management:

The Company had undergone Corporate Insolvency Resolution Process ('CIRP') under the provisions of the Insolvency and Bankruptcy Code, 2016 ('Code') subsequent to which resolution plan of National Asset Reconstruction Company Limited ('NARCL') has been approved by the Hon'ble National Company Law Tribunal, Kolkata Bench ('Hon'ble NCLT') vide order dated August 11, 2023. Accordingly, Board of Directors of the Company was re-constituted on 26 February 2024. The Board of Directors have re-constituted the Risk Management Committee & Asset Liability Management Committee consisting of senior executives of the Company. The Board of Directors have also approved relevant Company policies subject to review in due course of time.

- 1. The aforesaid Public Disclosure on Liquidity Risk as on June 30, 2025 is to be read in conjunction with the respective applicable notes given in the audited financial statement for the year ended as at March 31, 2025
- 2. Total Liabilities has been computed as sum of all liabilities (Total of balance Sheet less Total Equity).
