Sub: Intimation regarding Postponement of the date to consider and take on record the Unaudited Standalone and Consolidated Financial Results of the Company for the Quarter ended on 30th June, 2022

As intimated earlier to the Exchanges, the Reserve Bank of India ("RBI") has superseded the Board of Directors of Srei Infrastructure Finance Limited (SIFL) and Srei Equipment Finance Limited (SEFL) (a wholly owned subsidiary of Srei Infrastructure Finance Limited) (collectively "**Companies**") on 4th October, 2021 and appointed Mr. Rajneesh Sharma as the Administrator of the Companies in terms of Section 45-IE of the Reserve Bank of India Act, 1934 ("RBI Act") and accordingly the powers of the Board are vested in the Administrator. The RBI, in exercise of powers conferred under section 45-IE 5(a) of the RBI Act, had constituted a three member Advisory Committee to assist the Administrator of the Company in discharge of his duties. Further, pursuant to orders dated 8th October, 2021 of the National Company Law Tribunal, Kolkata Bench ("**NCLT**"), Corporate Insolvency Resolution Process ("**CIRP**") has been initiated against the Companies as per the provisions of the Insolvency and Bankruptcy Code, 2016 ("**Code**").

With reference to our earlier letter SIFL/SECT/FA/22-23/45 dated August 07, 2022, this is to inform you that due to unavoidable circumstances, the meeting to take on record the Unaudited Standalone and Consolidated Financial Results of the Company for the quarter ended on 30th June, 2022 along with the limited review report thereon by the Statutory Auditors of the Company scheduled for Thursday, the 11th August, 2022 is further postponed and re-scheduled to **Friday, the 12th August, 2022**.

Further, in continuation to our intimation dated 29th June, 2022 and in accordance with the Company's Code of Conduct for Prohibition of Insider Trading (Srei Insider Code), framed pursuant to the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, the trading window for dealing in the securities of the Company is closed from 1st July, 2022 and shall re-open after completion of 48 (forty eight) Hours of announcement of the aforesaid financial results of the Company to the Stock Exchanges.
