The Reserve Bank of India has filled insolvency proceedings against the Company in NCLT, Kolkata Bench. The Hon'ble Bench admitted the application on 08.10.2021 and Mr. Rajnesh Sharma has been appointed as a Admisnistrator. Further, Pursuant to order dated 08.10.2021 of the NCLT, Kolkata Bench, Corporate insolvency resolution process ("CIRP" has been initiated against the Company as per the Provision of the Insolvency and Bankruptcy Code. 2016. The Adminstrator shall carry out his functions as contemplated by sections 15,17,18,19 and 20 of the Code.
