Re: Resignation as Statutory Auditors of Srei Equipment Finance Limited ('the Company') from the FY 2022-23 and onwards

As you are aware, we were appointed as the Statutory Auditors of the Company from FY 2019-20 to FY 2023-24 at the 14th Annual General Meeting of the Company held on August 25, 2020. Further, the Reserve Bank of India ('RBI') vide 'Guidelines for Appointment of Statutory Central Auditors (SCAs)/Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and NBFCs (including HFCs) dated April 27, 2021 ('Guidelines') had restricted the tenure for appointment of statutory auditors maximum for a continuous period of 3 years subject to the audit firms satisfying the eligibility norms each year.

On completion of the audit for the financial year ended March 31, 2022, our firm has completed the tenure of 3 years as per the Guidelines and due to some unavoidable circumstances, we will not be able to continue to act as the Statutory Auditors of the Company till the conclusion of the Annual General Meeting in relation to the financial year ended March 31, 2022. Hence, we hereby tender our resignation as the Statutory Auditors of the Company with effect from July 07, 2022.

We request you to take the above on record. We shall send you the form no. ADT 3 after filing it with ROC.

We place on record our sincere thanks to the Company and the entire team for extending co-operation and support during our entire term.
