**Sub: Intimation of Closure of Trading Window**

In view of the proposed Public Issue by Srei Infrastructure Finance Limited (the "Company" or the "Issuer") of Secured Redeemable Non-Convertible Debentures ("Secured NCDs") of Face Value of Rs. 1,000/- each aggregating up to Rs. 11,000 Million and Unsecured Subordinated Redeemable Non-Convertible Debentures ("Unsecured NCDs") of Face Value of Rs. 1,000/- each aggregating up to Rs. 4,000 Million eligible for inclusion as Tier II Capital, totaling upto Rs. 15,000 Million ("Shelf Limit"), this Tranche Issue is with a Base Issue Size of Rs. 1,000 Million with an option to retain oversubscription upto the Shelf Limit i.e. Rs. 4,000 Million ("Tranche 1 Issue"), the trading window, in accordance with the Company's Code of Conduct for Prohibition of Insider Trading (Srei Insider Code), framed pursuant to the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015, shall be closed for dealing in the securities of the Company for all the Insiders (including Directors and Designated Persons as per Srei Insider Code) and their immediate relatives, from Wednesday, 3rd April, 2019 till Thursday, 11th April, 2019 (both days inclusive) i.e. completion of 48 hours from the date of opening of Tranche 1 Issue. The date of opening of the Tranche 1 Issue is Tuesday, 9th April, 2019.
