Srei reports consolidated PAT of Rs 105.14 crore in Q3 FY18 vs Rs 67.21 crore in Q3 FY17, registering a growth of 56%

Kolkata, **January 17**, **2018**: Srei Infrastructure Finance Limited ("Srei"), one of India's largest holistic infrastructure institutions, has reported consolidated PAT of Rs 105.14 crore for the quarter ended December 31, 2017 as against Rs 67.21 crore in the corresponding quarter of previous year, registering a growth of 56%. Consolidated profit after tax ("PAT") is Rs 267.57 crore during the nine months ended December 31, 2017 as compared to Rs 180.65 crore in the corresponding period of previous year, registering a growth of 48%.

The company's consolidated disbursements for the nine month period ended December 31, 2017 was Rs 16,147 crore as compared to Rs 12,102 crore in the corresponding period a year earlier. The consolidated disbursements for the quarter ended December 31, 2017 was Rs 5,731 crore as compared to Rs 4,812 crore in the same quarter of previous year.

Total consolidated income for the nine month period ended December 31, 2017 was Rs 3,860.80 crore as compared to Rs 3,355.35 crore in the corresponding period of previous year. Total consolidated income for the quarter ended December 31, 2017 was Rs 1,411.95 crore as compared to Rs 1,134.57 core in the corresponding quarter of previous year.

Consolidated assets under management ("AUM") stood at Rs 44,971 crore as on December 31, 2017 as compared to Rs 37,505 crore a year earlier.

Commenting on the results, **Mr. Hemant Kanoria**, **Chairman and Managing Director**, **Srei**, said: "The quarter ending December 31, 2017, has been overall good and we hope that the recovery in the infrastructure sector and growth in CME sector will continue in the New Year 2018.
