In the event of an early closure or extension of the Issue, the Company shall ensure that notice of the same is provided to the prospective investors through advertisements in a leading national daily newspaper on or before such earlier date of Issue closure or initial date of Issue closure, as the case may be.

Further, please note that the NCDs have been rated 'CARE AA- (Double A Minus)' (Outlook: Stable) by Credit Analysis & Research Limited ("CARE") and 'BWR AA (BWR Double A)' by Brickwork Ratings India Private Limited ("BRICKWORK") and are proposed to be listed on BSE Limited ("BSE") and National Stock Exchange of India Limited ("NSE"). BSE and NSE have granted its in-principle approval in relation to the Issue vide letter no. DCS/SP/PI-Bond/13/13-14





dated December 18, 2013 and letter no. NSE/LIST/225001-H dated December 18, 2013, respectively. For the purposes of this Issue, BSE shall be the Designated Stock Exchange.
