**Sub: Disclosure under Regulation 13(6) of the Securities and Exchange Board of India

Please note that Deigratia International Pte. Ltd. (hereinafter referred to as "DIPL/transferor") and Bharat Connect Private Limited (hereinafter referred to as "BCPL/acquirer"), are acting in concert with the Promoter (Mr. Hemant Kanoria) of Srei Infrastructure Finance Limited (the Target Company) and both, DIPL and BCPL are part of the Promoter/ Promoters' Group of the Target Company.

On 26th June, 2013, in an Off-Market transaction, BCPL acquired 1,70,00,000 Equity Shares from DIPL and 21,732 Equity Shares from Mr. Hemant Kanoria.
