Sub: Allotment of 38,69,41,535 Equity Shares of Rs. 10/- each fully paid up of the Company pursuant to the Scheme of Amalgamation

Please also note consequent upon the Scheme of Amalgamation (Scheme) of Quippo Infrastructure Equipment Limited (Quippo) into and with Srei Infrastructure Finance Limited (Srei and/or Company) becoming effective, the Committee of Directors of the Company at its meeting held on 5th March, 2011 have –

- a. allotted 9,29,15,839 Equity shares of ₹ 10/- each (fully paid-up) of the Company as Bonus shares by way of capitalization of free reserves to the shareholders of Srei in the ratio of 4 (four) equity shares of ₹ 10/- each (fully paid-up) for every 5 (five) equity shares of ₹ 10/- each (fully paid-up) held by the equity shareholders of Srei as on the record date (i.e. 11th February, 2011). Further, fractions arising out of the issue and allotment of the Bonus shares have been consolidated and the Bonus Shares, in lieu thereof, have been allotted to Mr. Salil K. Gupta, Chief Mentor & Director (Category Independent), who shall hold the said fractional entitlement shares in trust as trustee for the members entitled thereto, and shall sell the said fractional Bonus shares at such rate or at prevailing market rate, as deemed fit by him and pay to the Company the net sale proceeds thereof, for distributing to the Members in proportion to and in lieu of their respective fractional entitlements.
- b. allotted 29,40,25,696 Equity shares of ₹ 10/- each (fully paid-up) of Srei to the shareholders of Quippo in the modified share exchange ratio of 27 (twenty seven) equity shares of ₹ 10/- each (fully paid-up) of Srei for every 10 (ten) equity shares of ₹ 10/- each (fully paid-up) of Quippo held by the equity shareholders of Quippo. Further, in accordance with Clause 4.10 of the Scheme, 4,86,00,000 Equity shares of the Company (in lieu of 1,80,00,000 Equity shares held by the Company in Quippo) have been allotted to a Trust constituted under the name and style of 'Srei Growth Trust' consisting of Mr. Salil K. Gupta, Mr. V. H. Pandya and Mr. S. Rajagopal, Independent Directors of the Company as Trustees to the Trust for the purpose of holding the said Equity shares. Please note that pursuant to Clause 4.6 of the Scheme.
